F.06.4 LATE REPORT INTERNAL LOAN FROM WATER AND SEWERAGE FUNDS

PURPOSE

Due to a cash flow issue identified in Council unrestricted cash balances caused by the delay in recovery of capital grant funding from both the State & Federal Governments an internal loan will be required from the Water and Sewerage Funds.

RECOMMENDATION

That Council:

- 1. adopt the following internal loans due to delay in recovery of both State & Federal Government Capital grant funds outstanding:
 - Up to \$5 million from Water Fund;
 - Up to \$5 million from Sewerage Fund:
- 2. the internal loans are to be replenished by 30 June 2025; and
- 3. make a formal application for the loan approval to the Office of Local Government.

BACKGROUND

Over the last 4 years Council has undertaken an extremely large capital works program which has been predominantly funded by both the State and Federal Governments.

These projects have been funded through a myriad of funding models from progress claims after works completed to milestone payments at certain stages of the projects.

Currently the projects have progressed to the stage of intense construction activities to finalisation of the project and the requirement for funding body acquittals to be lodged and approved.

REPORT/PROPOSAL

This request is due to a cash flow issue identified which has been caused by the delay in recovery of capital grant funding from both State & Federal Governments.

It is projected to have outstanding at 30 June 2024, \$11 million in General Fund capital grant receivables as a result of significant major infrastructure projects. All projects are fully funded with funding deeds signed and the present shortfall is fully associated with late grant payments. The outstanding funds are due primarily from the following capital projects:

- Scone Regional Airport Minor project finalization and close-out acquittal reports
- Original Coulsons Creek Road (MR358) Project Close-out acquittal report
- Scone CBD Revilatisation Federal Government milestone claims post expenditure
- Moonan Brook Road Final milestone on completion of close-out acquittal report
- Local Roads & Community Infrastructure Projects Phase 1 & 2 close-out acquittal report.
- NSW Resilience Flood Damage State Government approval process for claims

Council has critically reviewed its projections to 30 June and anticipate a shortfall in unrestricted cash of \$9,771,033.

This shortfall does not include the possibility of funds received from any advances for the 2024/2025 financial assistance grants which have occurred in the prior years.

It is requested to utilise up to \$10 million through an internal loan from the residual balances of the Water and Sewer Funds as at 30 June 2024 to be replenished by 30 June 2025 through recovery of significant government capital grant receivables as at 30 June 2024.

The internal loan will be based on:

- up to \$5 million from the Water Fund; and
- up to \$5 million from the Sewerage Fund.

Council has reviewed the level of funds remaining in the residual balance of the Water and Sewer Funds, which excludes funds held for section 64 developer contributions and these Funds have sufficient available cash for their continued operations and projected capital works program for 2024/25. As Council receives the outstanding General Fund capital grant receivables these funds will be replenished.

The approval for the use of the internal loan from Water and Sewerage Funds is only an administrative process due to timing of government funding which have been approved in signed funding deeds.

A letter requesting approval has been forwarded to the Office of Local Government to utilise the funds under section 410 (3) of the Local Government Act 1993.

OPTIONS

- 1. Approve the use of Water and Sewerage Funds to facilitate an internal loan to the general fund due to delay in recovery of government capital grants.
- 2. Not approve the use of Water and Sewerage Funds to facilitate an internal loan to the general fund due to delay in recovery of government capital grants.
